

**CITY OF WHITING – JULY 19, 2022**

**MINUTES OF A SPECIAL MEETING OF  
THE COMMON COUNCIL OF THE CITY OF WHITING, INDIANA**

The Common Council of the City of Whiting met in special session on Tuesday, July 19, 2022 at 6:30 p.m. with Mayor Spebar presiding.

Mayor Spebar read the Notice of Publication sent to the Times on July 11, 2022 regarding the special meeting of the Common Council on July 19, 2022.

The agenda is as follows:

1. Approval of Accounts Payable Vouchers.
2. Any other matters to come before the Council with suspension of rules

The meeting will be held in Conference Room at Whiting City Hall, 1443-119<sup>th</sup> Street, Whiting.

**I. ROLL CALL**

Mayor Spebar, Councilmembers Michko, Michniewicz, Sarvanidis, Turpin, and Suarez were present, constituting a quorum. Also, present, was Clerk-Treasurer Haynes.

Attorney Sejna was absent.

Councilmember Sarvanidis made a motion to suspend the rules so that they may cover any other matters that come before the Council. Councilmember Michniewicz seconded the motion. Roll Call: (Voice) All Councilmembers voted aye. Motion carried unanimously.

**II. ACCOUNTS PAYABLE VOUCHERS**

Clerk-Treasurer Haynes presented Civil City Check #556-557E, 14925-14930, & 14933-14983 in the amount of \$342,407.50. Clerk-Treasurer Haynes amended the claims to add an invoice for Mechanical Concept Invoice # SD5039 for \$1,246.00. Councilmember Michko made a motion to amend the claims. Councilmember Michniewicz seconded the motion. Roll Call: (Voice) All Councilmembers voted aye. Motion carried unanimously.

Councilmember Michko moved to approve the Accounts Payable Voucher Checks as amended. Councilmember Turpin seconded the motion. Roll Call: (Voice) All Councilmembers voted aye. Motion carried unanimously.

Councilmember Sarvanidis made a motion to suspend the rules so that they may consider Ordinance No. CC-2022-2070 for possible 3<sup>rd</sup> and final reading. Councilmember Michniewicz seconded the motion. Roll Call: (Voice) All Councilmembers voted aye. Motion carried unanimously.

Councilmember Suarez presented Ordinance No. CC-2022-2070, an ordinance to amend the Whiting Municipal Code Chapter 17 to address some beach parking concerns.


